Call to order-The regular meeting of the Kinmundy City Council was called to order by Mayor Angela Diss with the saying of the Pledge of Allegiance.

Roll Call-Council members present were Amy Davis, Emily Hassebrock

and Gary Cooper. Council members Donna Smith, Corey Thompson and Curt Jones were absent.

Approval of Bills and Minutes-The motion was made by Emily

Hassebrock and seconded by Amy Davis to approve the bills and minutes from the September meeting. Yays-Emily Hassebrock, Amy Davis and Gary Cooper. Nays-none. Motion carried.

Mr. Keen-Mr. Keen stated he has received another ticket regarding his property. He contends that what the city is talking about is between the sidewalk and the street, and that the city owns that property: therefore he

He has a copy of the ordinance and it is his job to enforce them. He argued that she is his boss, and the city council is her boss so it can be changed. Mayor Diss said that our

Mr. West also took issue with the tree that is currently laying in the front yard. According to Mr. West, a different one fell while Jane Middleton was Mayor and the City cleaned that one up. He claimed that the trees died

Mr. West claimed he pressed charges against Kristen West, his brother's wife because she made the mess in the yard by dragging all the stuff out and burning it. On a visit to Kinmundy he spoke with the officer prior to Chief Duffy (Kevin Barry). He contends that the officer "grabbed his gun like he was scared of me in the City Hall." Mr. West alleges the officer said, "How would you feel if your property burnt down?" Mr. West alleges he said it three times. He called the Illinois State Police and told them, "If my property burnt down, two days later, he writes tickets to my wife that has no

system. He says he has emails from Mayor Middleton to confirm that the trees were the City's responsibility and would be cleaned up, so he wants

Mayor Diss responded that she was the one who wrote the first abatement notice and that all the council is asking for is the property to be cleaned up. clear. If Chief Duffy feels someone is in violation of a City ordinance he writes them an abatement notice and they have 10 days to correct the problem before a ticket is issued. Anytime in those 10 days, if they start working on it and showing improvement, they do not get a ticket. If they make an effort there will not be a ticket written. Chief Duffy writes it on the

notice. The only way they get a ticket is if they do absolutely nothing. He writes on the back the date he took the picture and usually between the time he takes the picture to the abatement sent is approximately 30 days. If the ticket is not paid and/or the problem not taken care of, he turns it over to the Mayor or Council to send it to the City Attorney.
