- b. ITEP grant-Illinois Department of Transportation-this grant aims at getting sidewalks built from Dollar General to the housing on North Monroe. The paperwork has been signed and returned to Mr. Gower. He stressed the need for letters from the community

Library Report-Amy Davis-Amy Davis read the library report stating they had 175 patrons, and 60 computer users for a total of 235 patrons. She reported 420 books were sent out, and 411 were received. The library paid \$412 for new books and deposited \$256. They deposited \$510 from Labor Day.
